Steam Distillation Process - Fir Needle Siberian

Steam is produced to begin the distillation process.



The plant material is placed into a still where it is subject to steam and vapour and a vacuum.



As the material is subjected to the steam distillation, a distillate of hydrosol-water (containing the water-soluble polar molecules) and essential oil (containing the oil-soluble non-polar molecules) is produced.



The essential oil is hydrophobic and having a different density to the hydrosol it either floats, or sinks. It is then tapped-off in Florentine flasks and any remaining traces of moisture removed.



The essential oil is then aired to remove any distillation notes. It is then packed and tested for quality control.
