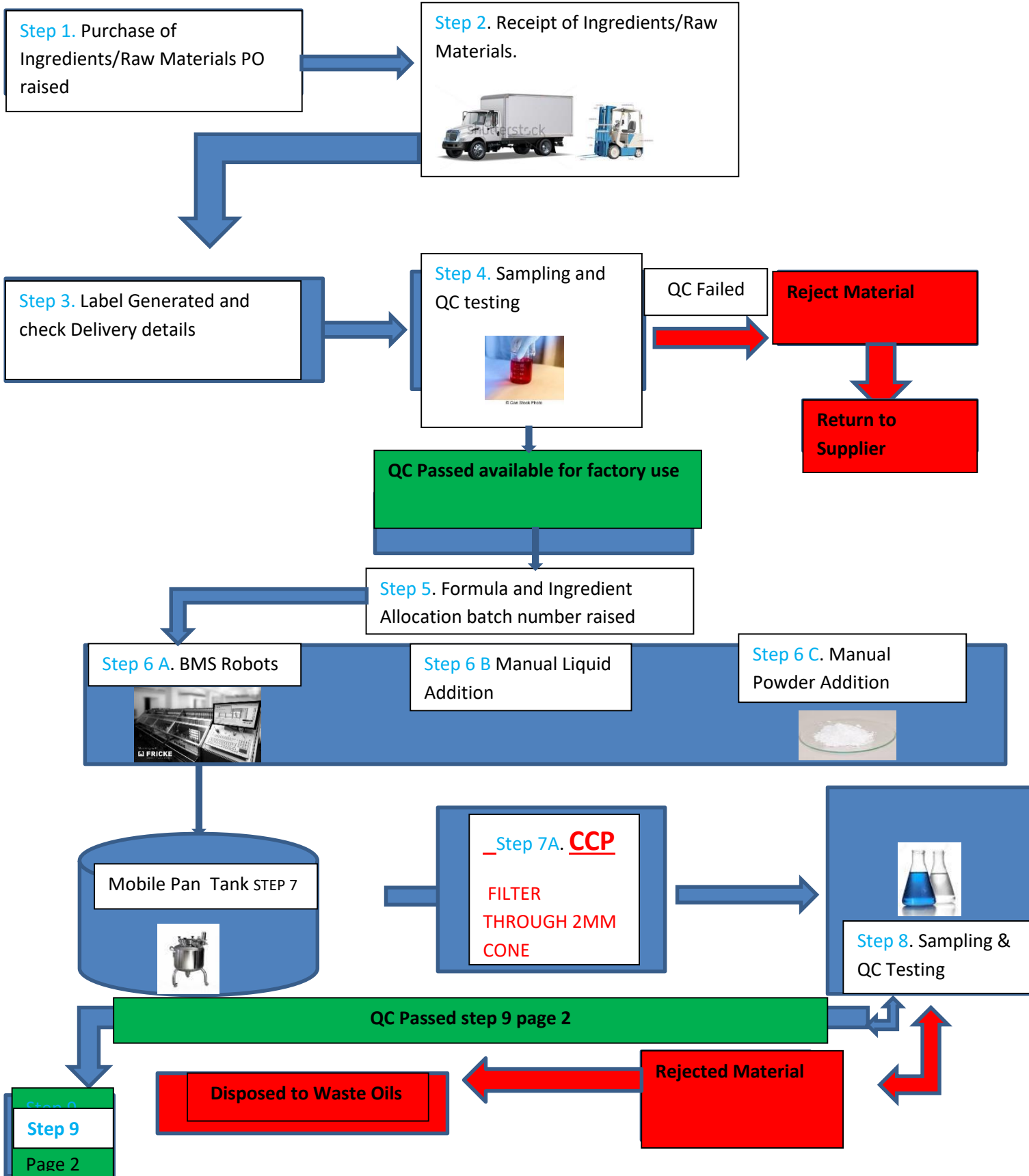

- Step 3.** Using Purchase ref labels are generated and delivery details recorded on local data base.
- Step 4.** All containers are sampled and submitted to QC for testing status change when passed and labelled.
- Step 5.** Order quantity is entered on Formpak to generate manufacturing batch form. Manufacture is assigned planning slot on spreadsheet.
- Step 6.** Product is manufactured according to works instruction /sequencing into mobile/pan/drum/tank Batch label applied.
- Step 7.** Product is mixed using appropriate stirrer until uniform.
- Step 7A** Product is filtered through 2 mm mesh CCP
- Step 8.** Finished product is sampled and QC test . Status change when passed and labelled.
- Step 9.** Product is filled into final pack.
- Step 10.** Batch label and shipping label is scanned using comparator to ensure correct material is present vs. order requirement.
